Since 2019, these volunteer Senior Sleuths have secured more than \$4.5 million in recoveries, refunds and savings for people seeking their help.

**Attorney General Moody Urges Consumer Financial Protection Bureau to Implement Measures to Help Human Trafficking Survivors Rebuild Credit**



Attorney General Ashley Moody is urging the Consumer Financial Protection Bureau to enact measures to help human trafficking survivors rebuild credit after escaping captivity. Attorney General Moody and 40 other state attorneys general wrote to the CFPB urging support of the intent of the Debt Bondage Repair Act in the agency's rulemaking implementing recent amendments to Section 605C of the Fair Credit Reporting Act.

Attorney General Ashley Moody said, "Survivors of human trafficking suffer physical and mental harm. Many also suffer financial damage. Their captors may open accounts in their name and destroy their credit scores—making it hard for survivors to rent an apartment, buy a car or even apply for a job. I am asking the CFPB to adopt rules in line with the Debt Bondage Repair Act and help human trafficking survivors start rebuilding their lives." [Read More](#)

Following the

congressional testimony of Department of Homeland Security Secretary Alejandro Mayorkas claiming the Biden administration's unlawful policies are not contributing to the influx of unvetted migrants, Attorney General Ashley Moody is releasing a federal document debunking that claim. The DHS document shows that the Biden administration has knowledge that its policies are encouraging mass migration. The document also reveals that the Biden administration continues to undermine public-safety immigration laws, while knowing that Mexican drug cartels are facilitating the surge at the southwest border to charge migrants for safe passage in order to "feed cartel violence in Mexico and along the border."

Attorney General Ashley Moody said, "This is a shocking discovery. It contradicts what the Biden administration has been telling the American people and shows that the Mexican drug cartels are profiting off the mass migration of unvetted immigrants to fund an increase in violence at the border.

"We are in the midst of a national opioid crisis and the deadliest drugs are being smuggled into our country from Mexico. President Biden knows this, yet he continues to double down on his terrible immigration policies knowing full well these policies are emboldening and enriching the very drug cartels who are profiting off the deaths of thousands of Americans." Along with 24 other Attorneys General, Attorney General Moody is demanding the U.S. Attorney General take action to safeguard and ensure the integrity of the rule of law.

Attorney General Ashley Moody said, "The integrity of our courts is paramount to a free and democratic society. Any attempt to threaten or intimidate United States Supreme Court Justices so they change their votes should be thoroughly investigated by the Department of Justice—not just for the safety of judges and their families, but for the independence of our nation's entire judicial system." **ONE PILL CAN KILL: Attorney General Moody Demands President Biden Take Action to Stop the Flow of Deadly Drugs on First-Ever National Fentanyl Awareness Day**



Attorney General Ashley Moody is warning Floridians about the dangers of synthetic opioids in recognition of the first-ever National Fentanyl Awareness Day. Fentanyl is a synthetic opioid 50 to 100 times more deadly than morphine—just two milligrams is enough to kill a full-grown adult—and oftentimes laced in counterfeit pills. The poisonous drug is now the leading cause of death for Americans ages 18 to 45.

According to a release from the National Institutes of Health, law enforcement across the country seized nearly 10 million counterfeit pills laced with fentanyl in 2021—a 50-fold increase in just three years. Per a report from the Commission on Combating Synthetic Opioid Trafficking, Mexico is now the top importer of fentanyl into the United States. Drug cartels are exploiting the border chaos to traffic drugs into the country.

Attorney General Ashley Moody said, “The shocking increase in the number of counterfeit pills laced with fentanyl should concern everyone, especially President Biden, who continues to ignore federal immigration laws—paving the way for these dangerous drugs to flood into our country. Nobody should use illicit drugs. Not only are they illegal, but they can be lethal. On this first-ever National Fentanyl Awareness Day, I am demanding that Biden take action and reminding Floridians that just one laced pill can kill.”

Florida Department of Law Enforcement arrested Tabria Anorria Josey, 20, of Loxahatchee on charges of scheme to defraud, grand theft, money laundering, aggravated white-collar crime and communications fraud. Josey is accused of stealing hundreds of thousands from dozens of victims in a complex real estate scam.

Florida Attorney General Ashley Moody said, "The defendant took advantage of Florida's red-hot real estate market to rip off homebuyers and renters. Her crimes spanned six counties, involved 25 properties and tricked consumers into parting with nearly \$300,000. As the investigation into this elaborate real estate scheme remains active, my Statewide Prosecutors will continue to work with law enforcement to ensure the defendant faces justice for her crimes."
